

Phase 1 Re-entry: June

Re-engagement of some academics and activities will be slowly and cautiously implemented during the month of June as long as specific guidelines are followed. This plan may be modified at any time by the superintendent or building administrators due to changes in guidance, local health data, or at the direction of public health agencies. Those not following protocols will be asked to leave.

June Activity	Participant Considerations	Required Actions
Summer School	Washington High School will offer student assistance classrooms to provide tutoring or supports associated with credit recovery and remediation of virtual courses with parental permission. (Ratio of 8:1 or better)	Groups of less than 10, with social distancing of 6' apart. Masks are highly recommended where applicable to protect all parties.
	Washington High School counselors to hold 1 on 1 sessions with students.	Staff screened for symptoms by a school nurse.
	Washington Middle School counselors to hold 1 on 1 sessions with students as needed.	Screening questions asked by counselors prior to student entry.
	Faculty planning team(s) for the purposes of planning for July summer programming and beyond as needed.	Staff responds to a series of screening questions before meeting/planning work. Maintain social distancing, masks highly

	WSPN- Adult LPN Program at FRCC utilizing a combination of online and face to face instruction in two groups with adequate 6' spacing in between students, cleaning procedures in place, and screening for symptoms.	recommended. Program nurses utilize the screening process and use/teach use of PPE along with all other recommended protocols in a classroom or clinical environment.
Athletics	Weight Room- Small groups of 8 students with 1-2 supervisors can utilize the weight room at one time with parental permission. (Not required of any athlete, strictly voluntary)	Hand wash before and after training, no touching face. Maintain 6' social distancing between athletes and coaches. Clean equipment before and after each use. Masks are highly recommended where applicable to protect all parties. (Cleaning solution spray bottles and towels will be used by athletes to wipe the equipment before and after their personal use. The spray bottles and towels will be cleaned as recommended between each group of students.)
	Skill Work- Coaches may organize small groups of 6-8, for non-contact skill work, students should use their own balls, water bottles, and towels. (Not required of any athlete, strictly voluntary)	Use of your own ball is required. Use outdoor facilities where possible. Handwashing before and after workout, avoid touching face, and maintain 6' social distancing. Masks are highly recommended where applicable to protect all parties. Skill work that requires sharing equipment (such as balls, gloves, batons, etc. will require the use of gloves, shared equipement will be disinfected after use) Demonstrations can be done at

Music/Instrument al Programs	Off in June as always	an appropriate distance and through verbal feedback and interaction.
Graduation Ceremony	A plan to social distance and manage crowd size will need to be developed and shared with the public health agency so appropriate advice and guidance can be obtained. Graduation to be held outside in a large open area. Consider dividing the graduates into groups and rotating in over a period of time. No final determination or decision regarding graduation has been made. Much of this plan will be contingent upon the Governor's Phase 2 Re-entry Plan and in accordance with local guidelines.	Seating 6' apart (students), Gathering of students prohibited, Picture arrangements and lines to accommodate wait time and distance, limit the number of spectators and group families together while otherwise meeting social distancing requirements. Details are TBD.
Prom	At this time, prom is not viable due to the inability to social distance in scheduled spaces and group size.	Postponed or modified, details TBD.
