

## Phase 2 Re-entry: June 16 - July 31

Phase 2 of re-engagement to academics and activities will be cautiously implemented during the months of June and July as long as specific guidelines are followed. This plan may be modified at any time by the superintendent or building administrators due to changes in guidance, local health data, or at the direction of public health agencies. Those not following protocols will be asked to leave. These are the next logical steps of re-entry. We appreciate your cooperation.

June/July Activity	Participant Information	Other Required Actions
Pre-K/Elementary Summer School	Pre-K/Elementary Summer School at Clearview, Marthasville, South Point, and Washington West locations with a student to teacher ratio of 14:1.  (*Pre-K programming is contingent upon staffing and need. Programming to be determined soon. If in session, Early Learning Center staff to student ratio will be 10:1.)  Students seated 4-6' apart, facing the teacher where applicable or spread throughout the classroom working on individual projects.	Masks are recommended where applicable, especially those that are immune compromised, to protect all parties. Staff and students will be health screened for symptoms. Anyone sick should not attend.  Custodial staff will utilize cleaning schedules and protocols consistent with the recommendations for cleaning and sanitizing high touch surfaces, classrooms, etc.

Summer school bus transportation is provided (Title only- see summer school letter from Dr. Straatmann); however, social distancing is difficult to monitor on a school bus. Siblings are encouraged to sit together. First Student will properly sanitize buses before and after each route. Due to the difficulty with social distancing on school buses, parents are encouraged to drop off and pick up students at school if possible.

First Student will follow safety protocols associated with sanitizing school buses during summer school and beyond.

Scheduled bathroom breaks for each class will ensure appropriate occupancy. Teachers will teach proper hand washing and will require hand washing upon exiting the bathroom.

Drinking fountains off. Water bottles may be used.

Frequent hand washing throughout the day, hand sanitizer may be used in the classroom or at stations located throughout the building. Cleaning of desk surfaces and other high touch areas to be done by the teacher and students within classroom procedures and by custodial staff each day.

Playground protocols will include handwashing before and after recess. Custodial cleaning of surfaces will occur on a daily basis. Students should bring a water bottle for their use that they sanitize and clean each day.

Breakfast and lunch will be served. Lunch staff will bring meals to classrooms. Students and teachers will sanitize desks before and after eating. Students will hand wash before and after lunch.

Nurses and staff utilize the screening questions provided by the Health Dept., and institute all other recommended protocols in a classroom or clinical environment.

Other staff professional development opportunities may exist and can be held on site with summer school with same protocols instituted.

## **Athletics**

## Weight Room:

Small groups of 20 students with 1-2 supervisors can utilize the weight room at one time with parental permission. (Not required of any athlete, strictly voluntary) Hand wash before and after training, no touching face. Maintain 6' social distancing between athletes and coaches. Clean equipment before and after each use. Masks are highly recommended where applicable to protect all parties. (Cleaning solution spray bottles and towels will be used by athletes to wipe the equipment before and after their personal use. The spray bottles and towels will be cleaned as recommended between each group of students.)

## Skill Work/Team Drills:

Coaches may organize small groups of not more than 20 or less in gyms (larger indoor spaces) and outdoor workout areas, for non-contact skill work, students are to wash their hands before and after drills or workouts. Equipment, such as balls, can be passed, caught or hit from player to player. Coach is to sanitize equipment after each group workout. Drills should still be cognizant of social distancing. Offense vs. defensive simulations may occur without guarding that requires contact. (Not required of any athlete, strictly voluntary.)

Use outdoor facilities where possible.

Handwashing before and after workout, avoid touching face, and maintain 6' social distancing. Masks are highly recommended where applicable to protect all parties.

Demonstrations can be done at an appropriate distance and through verbal feedback and interaction.

Band	Band rehearsals may occur inside in groups of not more than 20 (section rehearsals) while maintaining social distancing, outside rehearsals with the full band may occur outdoors with social distancing (6ft. apart). Students are to wash their hands, mouthpieces, instrument and case prior to arrival, before and after use.	Band instructors are to implement entry, exit, and transition plans conducive to social distancing, hand washing, and protocols as outlined by the Activities Director.
Camps (not to begin until July 13, unless otherwise directed by the Health Dept.)	This is full participation to include guarding man to man, tackling, and most normal operations for summer youth sports camps with parental permission and signed waivers.	Potential start date of July 13.
Waiver	Those participating in school activities/programs in July will complete and provide signature on the Parent Permission and Waiver of Liability for Student Participation Form.	Signed waivers will be kept on file in the AD's/Principal's office upon collection by coaches, and instructors/teachers.
